Having regard to Council Regulation (EU) No 2085/2021 of 19 November 2021 establishing the Joint Undertakings under Horizon Europe (hereinafter "Single Basic Act" or "SBA")¹ establishing the Clean Aviation Joint Undertaking;

Having regard to Article 17(2)(p), Article 19(4)(e), Article 20 (7)(g) and Article 21(7)(b), Article 26 (1) and Article 26 (2) of the SBA;

Having regard to the Financial Rules of the Clean Aviation Joint Undertaking adopted by the Governing Board on 16 December 2021² and in particular Article 23 thereof;

Having regard to the States Representatives Group and Scientific Advisory Body consultations and positive opinions;
