Decision of the Governing Board adopting amendment no 6 to the Clean Aviation Joint Undertaking Budget 2022-2023

THE GOVERNING BOARD OF THE CLEAN AVIATION JOINT UNDERTAKING,

Having regard to Council Regulation (EU) No 2085 2021 of 19 November 2021 establishing the Joint Undertakings under Horizon Europe (hereinafter "Single Basic Act" or "SBA") establishing the Clean Aviation Joint Undertaking¹, and in particular Article 17(2)(f) and Article 19(4)(b) thereof;

Having regard to the revised Financial Rules² of the Clean Aviation Joint Undertaking and in particular Articles 6(5), 15 and 17;

Having regard to the Governing Board Decision of 6 February 2023 adopting the Second Amended Work Programme and Budget 2022-2023³ and Governing Board Decision of 13 October 2023 adopting the Budget 2022-2023 amendment no 5⁴;

Having regard to the Clean Aviation Joint Undertaking Governing Board Rules of Procedure and in particular Article 11;

WHEREAS:

- 1) The SBA and Financial Rules of the Clean Aviation Joint Undertaking confer on the Governing Board the powers to adopt and amend the budget;
- 2) The Second Amended Work Programme and Budget 2022-2023 adopted by the Governing Board Decision of 6 February 2023 requires a specific amendment to section 4.1 in order to reinscribe recovered funds from administrative expenditures (€57 083), as well as a minor decrease (€46 670) of the Clean Aviation private members' contribution to the administrative budget 2023. This correction is due to the incorrect inclusion of two participants that will only accede to the members status end of 2023 and will start contributing to the Clean Aviation running costs only from the year 2024 (without retroactive effect).

The administrative expenditures have been adjusted accordingly with the revenues.

3) The proposed budget amendment is deemed necessary to ensure the sound implementation of the multi-annual budget. HAS DECIDED: Article 1 Section 3 "Budget" of the Second Amended Work Programme and Budget 2022-2023 is amended as follows: "The tables entitled 'Statement of Revenue' and 'Statement of Expenditure' are replaced by the Annex to this decision": Article 2 The Executive Director shall make the amendment no 6 to the Budget 2022-2023 publicly available on the website of the Clean Aviation Joint Undertaking. Article 3 This decision shall enter into force on the day following that of its adoption.
